



## Hydrogeologist

**Location:** Lake Forest, CA

**Job Description:** Wildermuth Environmental, Inc. (WEI) is currently recruiting for a Hydrogeologist. The candidate should be either a Licensed Hydrogeologist or a Certified Engineering Geologist, with a preference given to the former. The candidate will manage test-hole drilling, monitoring well installation projects, groundwater resource evaluation, and basin management projects.

**Essential Duties and Responsibilities:** The candidate must have hands-on experience designing and managing the construction of monitoring wells; preparation of lithologic logs; designing and implementing groundwater level and quality monitoring programs; interpreting aquifer stress tests, lithologic logs and geophysical logs; interpreting groundwater level and quality data; and integrating this information into groundwater management programs. The qualified candidate will work with other experienced hydrogeologists, but must also be able to work with minimal supervision on a variety of groundwater-related projects and investigations, aquifer test analysis, stratigraphic correlations, and regional hydrogeologic assessments.

**Qualifications:** Minimum requirements are a BA/BS degree in Geology and five years professional experience. Preference will be given to candidates possessing an MS or PhD degree in hydrogeology, and greater than five years of professional experience. Excellent verbal and written communication skills are essential. Must have the ability to prepare correspondence and technical reports (correct English usage, grammar, spelling, vocabulary, and punctuation) and to interpret data, technical reports, procedures, or regulations. Must possess the ability to clearly communicate verbally, exercise good judgment, and respond professionally to comments. Knowledge and experience with various software programs (Microsoft Office suite of products, including Word, Excel, Powerpoint, Project) is essential. Knowledge and experience with relational databases (Access, SQL Server, Oracle, EQuIS), geographical information systems (Arc/INFO, ArcGIS) and other ancillary software (gINT, S-Plus, SigmaStat/ SigmaPlot) would be considered a plus. The candidate should possess excellent time management skills to organize, plan, and prioritize assignments. Strong attention to detail and documentation skills. Must be reliable and conscientious. Ability to maintain effective and positive working relationships with others, cooperative and supportive team player, and work with a variety of people.
